EACH MEMBER IS DEDICATED TO PROMOTING, GROWING, AND FINDING SYNERGIES AMONG LOCAL NONPROFITS THROUGH INCREASED AWARENESS AND REGULAR INTERACTIONS. EACH NONPROFIT IS PASSIONATE ABOUT ITS INDIVIDUAL MISSION WHILE RECOGNIZING THE STRENGTH OF AN EMPOWERED NONPROFIT COMMUNITY. IN 2019, THERE WAS A 5% INCREASE IN NEW DCG MEMBERS, EXPANDING THE GROUP TO 47 UNIQUE AND DIVERSE ORGANIZATIONS. DCG HAS ALSO SEEN INCREASED PARTICIPATION IN TRAINING AND NETWORKING OPPORTUNITIES BY THE NONPROFITS.
